Upon acceptance all members shall be classified as "Probationary Members" for a period of not less than six months. Following the probationary period Associate members may apply for a Company Member. Associate members shall be entitled to have two voting representatives at the annual General Meeting or at any Extraordinary General Meeting.</p> <p><b>INDIVIDUAL MEMBER</b> Initial registration fee HK\$125.00 plus Annual Membership fee HK\$600.00.</p> <p>Individual membership is designed for individuals who have an interest in the Hong Kong Concrete Repair and Waterproofing Association Limited. They are entitled to one vote at Annual General Meeting or at any Extraordinary General Meeting.</p> <p><b>STUDENT MEMBER</b> Initial registration fee of HK\$37.00 plus Annual Membership Fee HK\$150.00.</p> <p>Student members must satisfy the main committee that they are attending a recognized full time educational or distance learning course. Student Members are not entitled to vote at any Association meetings.</p>
